#### OFFICE MEMORANDUM

Subject:-

Revise of pay of Judicial Officers under the Meghalaya Judicial Service Rules, 2006 and the Meghalaya Higher Judicial Service Rules, 2015.

The undersigned is directed to say that in pursuance to the Hon'ble Supreme Court order dated 27-07-2022 in All India Judges Association vs. Union of India & Others WPC 643 of 2015, the Governor of Meghalaya is pleased to revise the pay of Judicial Officers under the Meghalaya Judicial Service Rules, 2006 and the Meghalaya Higher Judicial Service Rules, 2015 as follows:

- 1. The new revised pay shall be as per pay matrix at **table 1** and applicable with effect from 01-01-2016 and shall be extended to all Judicial Officers against their existing pay. The existing allowances shall continue until such order being passed by Hon'ble Supreme Court.
- 2. The Judicial Officers shall be entitled to Central Dearness Allowance as notified by Central Govt. from time to time w.e.f. 01.01.2016.
- 3. The arrear pay shall be paid after deduction of the 30% interim relief in the following manner:
  - i) 25% in cash within a period of 3 months;
  - ii) Another 25% to be paid in cash within 3 months thereafter;
  - iii) The balance 50% has to be paid on or before the end of June, 2023.
- 4. The fixation of pay of the Judicial Officers to the new pay matrix shall be as per FR 23 (i) of the FRs & SRs, 1984.
