## Execution of Judicial whippings in Assam.

FROM THE INSPECTOR GENERAL OF JAILS, ASSAM, No. 2572, DATED THE 22ND SEPTEMBER 1903.

Asks for a decision on the question as to the persons by whom sentences of judicial whipping should be executed.

Under-Secretary,

Law does not provide as to the persons by whom the sentences of judicial whippings should be inflicted. It will appear from the enclosure to the Inspector General's letter that different classes of people are employed for the purpose in different districts.

Section 391 (2) of the Code of Criminal Procedure lays down that "the whipping shall be inflicted in the presence of the officer in charge of jail, unless the Judge or Magistrate orders it to be inflicted in his own presence." The High Court's criminal rule, however, has this "The Lieutenant-Governor of Bengal has ordered that where whipping is the sole punishment awarded, officers should make arrangements for having it carried out at once at the Magistrate's office," see also note on Section 390, Criminal Procedure Code.

#### P. S. Kar-25th September 1903.

Secretary,

I have not been able to find out what is the procedure in other provinces. Where whipping without imprisonment is the sentence, it is of course desirable that the whipping should be carried out at once at the Magistrate's court. A court constable seems the proper man for the perfermance of this duty at court. It should generally be possible in Assam to secure a constable, who has no objection to doing this work, in each subdivision. Such constable should be attached to the court office, and should carry out whippings when necessary at court. He might also he entrusted with this duty at jails when a sentence of whipping in addition to imprisonment is passed.

So far as I remember, in Bengal sentences of whipping alone were always executed by chaprasis. This was certainly the practice at some places where I served in Bengal. As it appears to be a general practice to employ court constables for this purpose in Assam, I agree to Under-Secretary's suggestion.

It degrades a man to execute a sentence of flogging, and I do not like the idea of employing either constables, peons or warders as executioners. In other provinces the kutcherry sweeper is employed. How many floggings are there annually at each district and subdivisional headquarters? Is there a sweeper to each cutcherry? If so, we could improve him into an executioner by the grant of an additional rupee or two a month.

In a large jail like Sylhet, a suitable convict might be obtained for whipping purposes to take the place of the sweeper. There appears to be a specially, trained convict for whipping, and in these circumstances, it might be well to employ him in all cases. But we might add that the person who is trained for this purpose should be a convict of very low caste, and that he should be credited with marks for every whipping he inflicts.

#### Secretary,

It appears to me essential that if whippings are to be really effective, they should be carried out by a trained man, in a large jail like Sylhet, a special long-term convict might be trained for the purpose as is the present practice; in subdivisions like those of Sylhet and in the Garo Hills whipping might be inflicted by the lock-up sweeper, who is always a long-term convict, and I think always of low caste. As suggested by Mr. Donald marks might in both cases be given for whippings.

It seems to me essential that whippings should be inflicted by a convict as police chaprasis and ordinary sweepers are, I am convinced, frequently hampered with by the friends of persons sentenced to be whipped, and thereby induced to perform their task in a very perfunctory way.

I have the honour to request that you will be good enough to obtain the decision of the Hon'ble the Chief Commissioner on the question as to by whom sentences of judicial whipping passed under sections 390 and 391 of the Code of Criminal Procedure, should be executed. In this province, there is no uniform practice in this matter, in some districts such sentences are carried out by court peons, while in others they are carried out by a convict from the local jail. A precis of the replies received from the several Deputy Commissioners to whom a reference has made on the subject is enclosed herewith. The Deputy Commissioner of Darrang says that sentences of judicial whipping in his court and in the courts subordinate to it are executed by convicts, because "the chaprasis have caste prejudices against the work". I am not aware if this is the case in some other districts, but the point is to decide whether, if court peons have their caste prejudices against this work, it is proper to compell prisoners to do the same against theirs. It is, moreover, desirable that there should be one uniform practice throughout the province.

No. 215.

Precis of replies received from the several Deputy Commissioners in Assam regarding the practice of executing judicial sentences of whipping.

Nowgong.—By court constables, in cases in which the sentence is one of whipping only, but by convicts in cases in which sentences of whipping and imprisonment are combined, the former being executed in jail when the time allowed for appeal has expired.

Cachar .- As in the Nowgong district.

Naga Hills.— Ditto.

Lushai Hills.— Ditto.

Garo " — Ditto.

Kamrup.— Ditto.

Sylhet.— Ditto, but when a sentence of whipping is passed in addition to imprisonment, it is executed in jail by a warder, and not by a convict.

In forwarding herewith copy of a letter No. 804L.J., dated the 9th February 1904, from the Deputy Commissioner of Sibsagar, regarding the execution of whipping by court sweepers, I have the honour to say that I have ascertained that there is no whole-time sweeper attached to any cutcherry in this division. In Darrang, Nowgong, and Lakhimpur the courts are swept by convicts deputed from the jails who do not get anything for it. In Kamrup there are court sweepers, but they are not whole-time servants. In Goalpara the subdivisional court is swept by a sweeper from the sub-jail, and the sadr court by a sweeper who works at the dâk bungalow and gets Rs. 3 per month for it. I propose, therefore, with the Chief Commissioner's permission, to instruct Deputy Commissioners that, where there is no kutcherry sweeper the whipping should be inflicted by the jail sweeper, who is always, I believe, a convict.
